

Social Networking Policy

1. Information on the data controller hosted on the official website of GESTIHOTELS ALEGRIA S.L., on the social network

In accordance with the duty of information established in Regulation (EU) 2016/679 of 27 April (GDPR) and Organic Law 3/2018, of 5 December (LOPDGDD) **GESTIHOTELS ALEGRIA S.L.**, hereinafter the Manager wishes to inform of the users of this social network the policy regarding the treatment and protection of the personal data of those people who voluntarily access and use the official page of the **RESPONSIBLE**, in the same. The access and use by the user of this official page of the **RESPONSIBLE**, supposes that he expressly accepts this privacy policy and that he gives his consent for the treatment of his personal data according to the foreseen in the same.

2. Data on minors or the disabled

The access and registration in this social network is prohibited to the minors of fourteen (14) years, so that also the access and use of the minors of fourteen (14 years) to the official page of the **RESPONSIBLE**, in the same is prohibited. For its part, if the user is incapable, the **RESPONSIBLE**, warns that the consented assistance of the holder of the parental authority or guardianship of the user or his legal representative will be necessary for the access and use of this official page of the **RESPONSIBLE**, he will be expressly exonerated from any responsibility that could derive from the use of his official page by minors and incapable being said responsibility of his legal representatives in each case.

3. Identification of the company name of the person responsible for the file

The user is informed that the **RESPONSIBLE**, with registered office at **Road N II, Km 672.6 - 08398 Santa Susana (Barcelona)**, is responsible for the files and processing through which the data is collected and stored. personal data of the user as a result of the registration and use of the official page of the **RESPONSIBLE**, in this social network, without prejudice to the treatments for which the entity in charge of the social network in which our official page is located is responsible.

4. Purposes for which personal data, information and consent are intended

5. Identification of the recipients in respect of whom the RESPONSIBLE provides for the transfer or communication of data

6. Other third party service providers
